

Dog Boarding - Terms and Conditions

- 1. Boarding fees are £25.00 per dog per day or part day, in residence, e.g.: a dog dropped off and then collected the following day in excess of a 24hr period may incur a full day's charge for both respective days. Please note: Perkins Pet Services reserves the right to use discretion on boarding fees.
- 2. A non-refundable deposit of £50 is to be paid at time of booking and the remainder of the fee to be paid upon collection of your dog.
- 3. Please bring your dog's bed, collar lead, food bowl and enough food for the duration of your dog's stay. Should pets require any additional supplies whilst in the care of Perkins Pet Services, these will be purchased and added to the bill
- 4. Your dog must wear a collar/harness and ID tag with the correct, legal information on (Owner name, address inc. postcode and phone number)
- 5. Perkins Pet Services must be alerted to any behavioural problems with their pet(s) at the time of booking and at any time they occur during the time of contract. Failure to do so may result in additional charges or cancellation of any future contract.
- 6. All dogs must be older than 3 months of age. They must be compatible with other dogs, preferably familiar with common commands and trustworthy off the lead if you would like them to run around off of it.
- 7. No dog registered under the Dangerous Dog's Act is accepted for boarding.
- 8. All dogs must be up to date with their vaccinations including: Bordetella Kennel Cough, Canine Distemper, Infectious Canine Hepatitis, Leptospirosis, Canine Parovirus and any other relevant diseases. The course of vaccination must be completed at least 4 weeks before the first date of boarding in accordance with veterinary and/or manufacturer's instructions.
- 9. All dogs must be on a regular flea and worm regime.
- 10. No dog will be accepted without a current vaccination certificate.
- 11. The client is responsible for any veterinary bills, no matter how they are incurred, whilst pets are in the care of Perkins Pet Services.
- 12. Reimbursement for damage or veterinary costs incurred by your dog during its stay will be expected to be paid for in full upon collection of your dog.
- 13. Whilst every care is taken to make your dogs' stay with us a happy and enjoyable one, please note that all dogs are left at their owners risk and no responsibility can be accepted for sickness, injury or demise of the dog.



- 14. A/The person you name as your Contact should be someone that you trust to take full responsibility for your dog's welfare in the event of an incident of any kind preventing your dog from completing its stay.
 B/ You consent to Perkins Pet Services consulting a veterinary surgeon should they in their reasonable opinion consider it necessary for the wellbeing of your dog; and to them acting upon the advice of the veterinary surgeon in the event that you or your Contact are not available. Perkins Pet Services's primary care vet is Strathmore Veterinary Clinic, London Road, Andover. Should your dog require veterinary attention during its stay, this is the veterinary practice that your dog shall go to unless you specifically state otherwise.
- 15. Although Perkins Pet Services holds Public Liability insurance, wherever possible pets should be insured by the client. Perkins Pet Services reserves the right to refuse a booking for any animal which is not insured.
